**WAIVER OF JURISDICTION OVER**  
**CIVIL INFRACTIONS COMMITTED BY JUVENILES**

**IT IS ORDERED:**


Pursuant to MCR 8.112(B), MCL 712A.2e, and MCL 600.8379(1), the 17<sup>th</sup> Circuit Court and the District Courts for the County of Kent enter into the following agreement:

1. The circuit court waives jurisdiction over civil infractions alleged to have been committed by juveniles within the geographic jurisdiction of the district courts, excluding alleged curfew violations, alleged violations of MCL 436.1703(1)(a), and alleged violations of MCL 333.27965.
2. Upon execution of this agreement, the district courts have jurisdiction over the juvenile in the same manner as if an adult had committed the civil infraction.
3. The assessment and distribution of fines and costs shall be as if an adult had committed the civil infraction.


Copies of this administrative order shall be provided to all affected law enforcement agencies. Any modifications are subject to approval by the State Court Administrative Office.




