## How to File a Custody or Parenting Time Complaint with the FOC

If you feel that a custody or parenting time order has been violated by the other parent on your case, you may file a complaint with the FOC. To file a complaint with the FOC, please fill out the attached form.

## **Submit Online**

### Computer/Laptop

- 1. Fill out the form below in a pdf viewer, such as Adobe Reader (available for free here)
- 2. After you have filled out the form and signed it with your electronic signature, save the form and then go to the <u>FOC Form Submissions Page</u>.
- 3. Fill in your name, email address, phone number, and case number on the Form Submission page. Attach your completed form at the bottom of the page by clicking the "Choose File" button. NOTE: There is a file size limit of 2MB, and only PDF, JPG, and PNG files are accepted.

#### **Smart Phone**

- 1. Install the Adobe Acrobat Reader App on your phone, for free.
- 2. Open the form, using the Adobe Acrobat Reader App. You can then fill in, sign and save the form on your phone.
- 3. After you have completed the form, save and then go to the FOC Form Submissions Page.
- 4. Fill in your name, email address, phone number, and case number on the form submission page. Attach your completed form at the bottom of the page. NOTE: There is a file size limit of 2MB, and only PDF, JPG, and PNG files are accepted.

## Not sure if you should file a complaint? Please keep the following in mind:

- The FOC can pursue enforcement on custody or parenting time orders that are specific and contain days and times. We cannot enforce "reasonable parenting time" or "parenting time as the parents agree."
- o The FOC cannot enforce agreements of the parents that are not part of a court order.
- o Complaints must be filed within 56 days of the alleged order violation.
- Possible outcomes of filing a complaint are:
  - FOC takes no action because the complaint isn't actionable. If this is the case, you will receive notification and an explanation. The FOC will let you know what other FOC services or options may be available.
  - Your complaint is processed for enforcement. If this happens, the complaint will be sent to the other parent for response. The other parent has the opportunity to respond and their response will be sent to you.
    - If your complaint is processed for enforcement, the FOC may schedule a joint meeting prior to taking the case to court.
    - Your case may be scheduled for a court hearing, and the court will decide whether to order make-up parenting time and sanctions (fines, fees, incarceration).
    - If the court finds a parent submitted a complaint in "bad faith", that parent could be sanctioned by the court.
