## FOC SUPPORT ENFORCEMENT

### How will I know if FOC is enforcing child support on my case?

If you are a parent who pays support, **you will receive a notice** that enforcement action has begun. This notice could be a letter, email, text message, phone call, or any combination of these. This notice is provided when an arrearage (past-due support) is identified on your case. With this notice, FOC may request you contact us or provide information about why you are not paying your court-ordered support. Not responding to this request could result in further enforcement actions on your case, including an Order to Show Cause (OTSC) hearing being scheduled at the court.

Please be sure your contact information is up to date with FOC. Otherwise, you may miss important notifications. You can **update your personal information** [here](#). If you receive a notification, please reach out. FOC would like to resolve the matter with you and help you understand your order and options available to you.
