DESCRIPTION OF INCIDENT:

On 1/6/15 at 0808 hrs, the Kent Co Sheriff's Office, Cutlerville Rescue and Life EMS responded to the report of a pedestrian struck at S. Division Ave and Marcus St SW, Byron Twp. This intersection is about two blocks north of 68th St. The pedestrian was found responsive in the roadway but seriously injured. Witnesses advised the pedestrian, Hagen, had just dropped his vehicle off at a repair facility on the east side of S Division, and looked to be walking across the street to a restaurant on the west side. As he was crossing the southbound lanes, he appeared to slip or trip, and fell into the path of a southbound vehicle driven by Koetje. She was not able to avoid Hagen on the icy roads. Hagen was transported to Butterworth where he is being treated for serious but non life threatening injuries.
